Carryforward Notes or Other Budget Notes, If applicable:

USP began receiving HESSR funds for the first time in 2020-21, following the passage of the 2019 Highlander Empowerment Student Services Referendum. For this year only, USP did not receive any summer fees. USP had no funds to carry-forward from the previous year. USP did not need to pay a VCSA Assessment Fee since it's based on prior year's funding, which was zero. Finally, UCR continued in a remote learning environment for the entire 2020-21 academic year due to the COVID-19 pandemic.
